§ 5.1 Civil Service regulations. The Director, Office of Personnel Management , shall promulgate and enforce regulations necessary to carry out the provisions of the Civil Service Act and the Veterans' Preference Act, as reenacted in title 5, United States Code, the Civil Service Rules, and all other statutes and Executive orders imposing responsibilities on the Office.

Other provisions of the regulations notwithstanding, employees of the Health Department with permanent status in part-time or hourly Civil Service positions in the Medical (4D) series of classes who are re-assigned to a full-time position in the same class or a lower level class in the Medical (4D) series of classes may be appointed at any pay step in the pay range for the class as determined by appointing authority.
